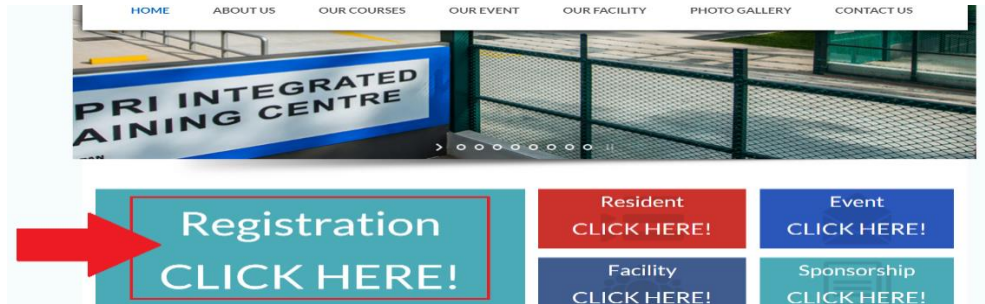


User Guide for Registration of courses (New Corporate Sign Up)

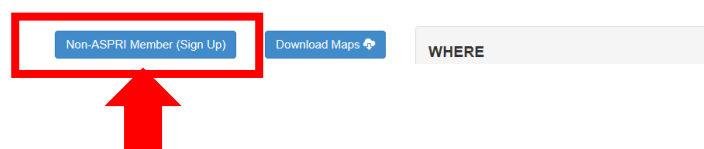

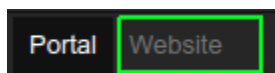
